Meeting was called to order at 11:05 AM 11-11-2017

BOARD MEETING:

Meeting called to order at 10:30 AM by President Steve Hoyt.

Board members in attendance were President Steve Hoyt, Vice-President Mike Pimentel, Treasurer Jim Utley, Members-at-Large Norm Coates and Burt Rosensweig and Secretary Jeff Whitney.

ITEMS DISCUSSED:

Gravel has been added, but the fill was no longer clean fill; there was a lot of crushed concrete and it was noted to be on the watch for rebar and wire mesh as it may penetrate your tires. No more fill is needed at this time. Be careful of the bare dirt in the parking area as it has not been compacted and with the wet weather approaching it is possible to get stuck out there.

Also noted was a request from at least one of the animal keepers to keep the gate closed. There is a bit of pink rope that can be used to

keep the gate closed, Jim U will get some chain to replace the rope. If the gate is open when you enter or leave, just close it and secure it with the rope or chain. If you are leaving and are the last one then lock the gate (lock-to-lock as usual).

There was some discussion of the ownership of the shed – the last tenant of the house apparently stopped by and was asking for money for the shed. Some county workers had been out sometime prior to that and in a discussion with Jim Utley and a couple of other members a county worker had stated that the county had bought the shed for the previous tenant. It was decided that if the last tenant could provide proof of ownership we would discuss compensation with him.

The board meeting was adjourned at 11:00AM.

Treasurer's Report:

Jim Utley gave the Treasurer's report and noted that we are solvent, and will be making our annual donation to the Viola Blythe Foundation. The report was accepted as read. Jim also noted that the Membership Renewal form was available on the website (http://sacrc.org/pdf_files/2018_RENEWAL.pdf).

Safety Report:

Norm noted that people have become lax about arming and disarming their model. ALL models are to be armed in the hot pit (the designated area). NO models shall be armed, started or flown in the general pit area. NO EXCEPTIONS. Well – one exception – if your model stops at the North end and cannot be taxied back for some reason you may DISARM it at the last table to the North. DO NOT carry an armed model thru the pit area. Glow and Gas models should be fueled in the hot pit area.

Field Report:

Norm Coates noted that the fabric at the South end of the runway had blown up in the last couple of storms; he and Brady Dietrick nailed it back down and use more nails than previously. Next time Norm has his tractor out he will see about covering the very end of the fabric with some dirt to prevent the blow up again. The field crew lined the parking lot and put out parking bumpers. If you are ever out on a weekday or see them on a weekend be sure to thank the weekday fliers for their efforts!

Ownership of our new shed was discussed (see the Board Meeting minutes).

As noted in the Board minutes – the animal people have asked us to keep the gate closed (not locked) in order to prevent the animals from wandering into the street. If you are the last one leaving the field, then please lock the gate (lock to lock).

Art Vargas noted that the impound board had been left unlocked a couple of times. The key to the lock box used to be stored there, and the keys to the shed and container used to be in the lock box. Art moved all of the keys into the shed – if you need into the shed or container there are usually several people at the field with keys (most of the board and a few select others).
