## **Board Meeting Minutes:**

Steve Hoyt, the incoming President discussed the possibility of changing the by laws. Per the club rules this requires notification in the newsletter for a month in advance, a quorum of at least 20% of the club members and a 2/3 vote of members present.

There was also a discussion of voting in 2 members of the board, which was agreed to by the board. We also discussed reconsidering the rule for approving new club members after attending one club meeting, as in the past there have been problems with new members following the established rules.

Steve Hoyt took over as President from Jim Solar after the last election.

#### Old Business:

Introduction of Steve Hoyt as the new club President. There was a discussion of the need for Field Marshalls. Steve Hoyt asked Lou Morales to look into appointing them. The club officers were elected last month, however the at large members were not elected at that time. A vote of the membership present was taken and Lou Morales and Jeff Whitney were elected. Jeff Whitney will be taking over the newsletter.

#### **New Business:**

Possible changes to the club by laws were discussed, it takes a minimum of 20% of the membership to establish a quorum and 2/3 of the members present must approve any changes. This will be reviewed in January 2014. A determination needs to be made as to if the Safety Officer needs to be appointed by the board or elected by the club members. Jeff Whitney is currently working on updating the club website. Bob Freshwater indicated that the monthly raffle is losing money. It was asked if we want to continue doing the raffle every month. It was suggested to change the raffle to once a quarter, this was approved by the membership. Jeff Whitney brought up the idea of bringing in guest speakers to the club meetings perhaps doing 'RC 101" i.e. teaching. This would include plane building, demonstrations etc. Bob Freshwater said he would be willing to show us how to work with blue foam. Lou Morales said he would show a night flier and how to prevent corrosion on float fliers. Field Report: Bob Freshwater finished the 3 bridges over the gulley, we will be adding stakes & yellow caution tape to mark off the gulley. We have approval to move the fence at the arming station back. We are waiting for

some damp weather to make this easier. WE need to work on removing the palm tree from the area nest to the shed with the weather station as it is causing problems with the integrity of the building. The cover over the pit area will be removed some time in the next couple of weeks. We need to consider placing a tarp to cover the roof of the weather station. The purchase of a tarp was approved. We also need to look at the roof over the impound area/ transmitter shack to see if it needs work.

Safety Report: Per Lou Morales everything is OK. There was an incident where a plane went into the water the pilot wanted to go out alone. This is not safe is it is anywhere near the water, if your plane is in the water you need someone to go with you to avoid problems. A member found some rat poison at the field. We are in a nature reserve and need to be careful about what we leave behind.


